

NOTICE OF MEETING TO VOTE ON TAX RATE

A tax rate of \$0.994555 per \$100 valuation has been proposed by the governing body of Crockett County.

PROPOSED TAX RATE	\$0.994555 per \$100
NO-NEW-REVENUE TAX RATE	\$1.152298 per \$100
VOTER-APPROVAL TAX RATE	\$1.227002 per \$100

The no-new-revenue tax rate is the tax rate for the 2026 tax year that will raise the same amount of property tax revenue for Crockett County from the same properties in both the 2025 tax year and the 2026 tax year.

The voter-approval rate is the highest tax rate that Crockett County may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that Crockett County is not proposing to increase property taxes for the 2026 tax year.

A PUBLIC MEETING TO VOTE ON THE PROPOSED TAX RATE WILL BE HELD ON August 25, 2026 AT 8:00 AM AT Crockett County Commissioner's Court.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, Crockett County is not required to hold an election to seek voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Crockett County Commissioner's Court of Crockett County at their offices or by attending the public meeting mentioned above.

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.

The following table compares the taxes imposed on the average residence homestead by Crockett County last year to the taxes proposed to be imposed on the average residence homestead by Crockett County this year.

No-New-Revenue Maintenance and Operations Rate Adjustments

Indigent Defense Compensation Expenditures

The Crockett County spent \$65,826 from July 1, 2025 to June 30, 2026 to provide appointed counsel for indigent individuals in criminal or civil proceedings in accordance with the schedule of fees adopted under Article 26.05, Code of Criminal Procedure and to fund the operations of a public defender's office under Article 26.044, Code of Criminal Procedure, less the amount of any state grants received. For the current tax year, the amount of increase above last year's indigent defense compensation expenditures is \$23,049. This increased the no-new-revenue maintenance and operations rate by \$0.000114/\$100.
